




- Preliminary allocations anticipated by April 1

  - ✓21st CCLC grants (Cohorts FY16, FY18, and FY20)
- FY20 Grant Award Notifications (GANs)
  - ✓ Loaded directly as attachments to the Con App

## Internal Operations: Monitoring Grantee Drawdowns



- Revised procedures to standardize our drawdown monitoring responsibilities
- Individual program managers will review monthly drawdown reports and conduct outreach
- LEA replies:
  - ✓ Current balance reflects timeline of approved CLIP activities
  - ✓ Aware that drawdown is lagging temporarily
  - X Unaware that drawdown is low
  - X Current allocation lacks approved budget






- 1. Application opens in SLDS on March 1, 2019

### Office of Elementary and Secondary Education (OESE)



- As of January 2019, ED has consolidated OESE and the Office of Innovation and Improvement (OII) into a single office, under the title of OESE.
- "New structure will provide greater efficiency, better support, and more effective coordination to our grantees and stakeholders"
  - Streamlining our contacts with states and grantees through the new State and Grantee Relations Office;
  - Ensuring a focus on identification and dissemination of best and promising practices in the field and lessons learned from our grantees through the *Office of Evidence-Based Practices*;
  - Providing an opportunity for the Grants Management Offices to focus on the most effective outcomes for each program and how to provide high-quality support to grantees; and,
  - Aligning the technical assistance occurring across OESE, including with our external partners, to provide coordinated assistance for States and grantees with the *Program and Grantee Support Services Office*.
